Amendment notes

This amendment explains the revision of Vicmap Change Notice #288.1 published 10/10/2022.

1. Modified implementation schedule.

The revised Vicmap Change Advisory Notice #288.2 is provided below.

What is happening

Due to operational issues around loading the DCM adjusted LGA data into the Vicmap statewide datasets, the data integration phase of the Digital Cadastre Modernisation Program has been rescheduled. This will allow the necessary time to resolve these issues. A delay of approximately four weeks is anticipated.

This change notice informs the updated integration schedule.

Why this change is occurring

We listened to our stakeholders and we are incorporating some improvement opportunities to ensure smoother data integration. These considerations are balanced with the requirements of our regular data maintenance program.

Who will it affect

This change will affect all Vicmap customers who consume data for the following Local Government Areas:

DELWP is working to re-schedule the LGA integrations to reflect the 4 weeks delay. A revised state-wide LGA roll out schedule will be included within a future Vicmap change notice.
