Amendment notes

This amendment explains the revision of Vicmap Change Notice 297 published 23/03/2023.

1. The implementation date has been deferred, until the 21 July 2023, due to the process being dependant on software changes.
2. Further clarification about the change has been provided with the addition of diagrams.

The revised Vicmap Change Advisory Notice 297.1 is provided below.

What is happening

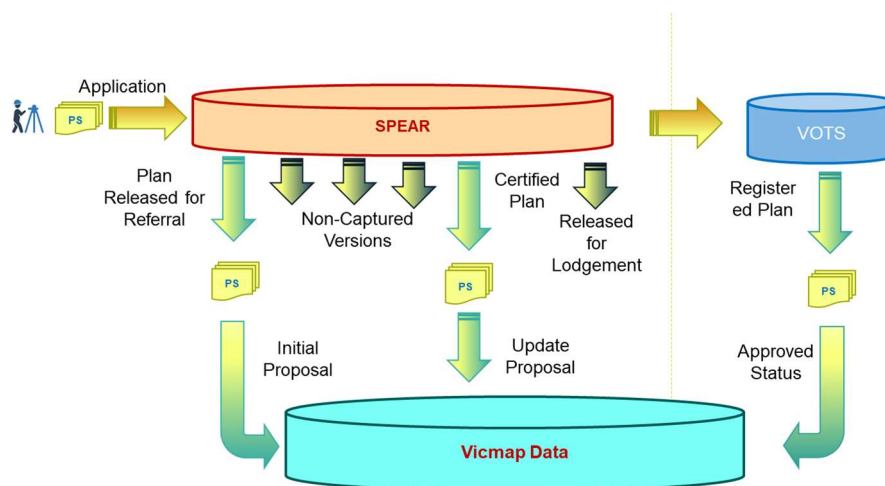


Figure 1: Current process for maintaining proposed plans of subdivision in Vicmap Property.

The process for maintaining Vicmap Property will be slightly altered. Currently (Figure 1) Vicmap Property captures proposed plans of subdivision at:

1. the initial Plan Released for Referral, and
2. once the referral authorities have confirmed compliance Vicmap Property is updated with the Certified Plan.

From July 2023, Vicmap Property captures proposed plans of subdivision at:

1. the initial Plan Released for Referral, and
2. the Released for Lodgement version of the plan.

The change in process means the time between when a proposed plan of subdivision enters Vicmap and when it is updated will be extended, on average, 3 months.

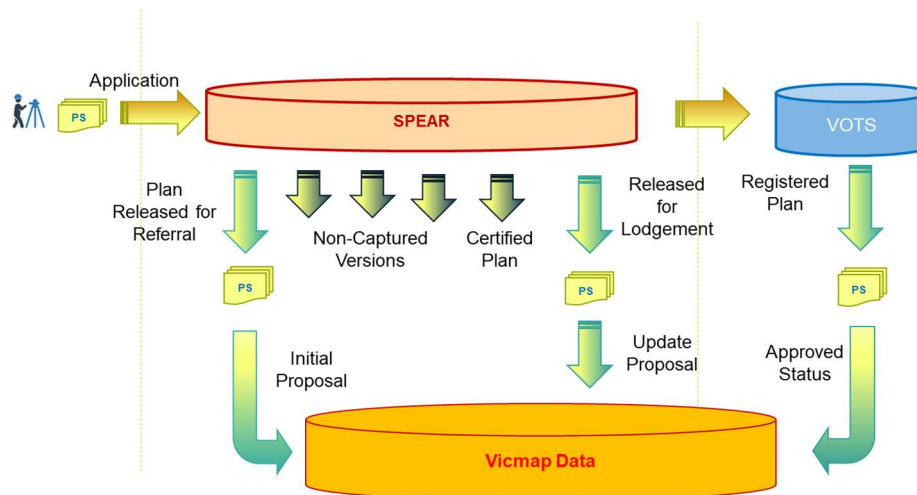


Figure 2: Future state process for maintaining proposed plans of subdivision in Vicmap Property.

Why this change is occurring

1. It will streamline our work practices within Land Use Victoria.
2. Capturing the Released for Lodgement plan will guarantee that no changes will occur between this version and what is being lodged for registration at the Plan Registration Branch.

Who will it affect

All Vicmap Property customers that utilise the certified plan for planning purposes.

When the change will occur

These changes will take effect on **21 July 2023**.
