# Change advisory notice 286 - Vicmap Property, modified domain values for the ADJUSTED attribute in the CAD\_POINT table

## What is happening

From 31 May 2022, the domain values of the attribute ADJUSTED within the CAD\_POINT table will be modified. The change will replace the existing 'Y' and 'N' domain values to provide customers additional adjustment status information.

The table below provides the modified domain values for the ADJUSTED attribute in the CAD POINT table.

Attribute	Domain	Definition
ADJUSTED	Α	'A' indicates that the point has been adjusted
	М	'M' indicates that an adjusted point has been moved during the incorporation of new maintenance data.
	U	'U' indicates that this point has not been adjusted

Table 1: Proposed changes to the domain values for the ADJUSTED attribute in the CAD\_POINT table.

Please note, the data models for Vicmap Property remain unchanged. The data dictionary with the Vicmap Property Data Product Specification will be updated with the modified domain values for the ADJUSTED attribute in the CAD\_POINT table.

# Why this change is occurring

In October 2022¹ the Department introduced the CAD\_POINT table that included the ADJUSTED attribute. Initially the cadastral points were assessed as either adjusted or unadjusted and domain values for the ADJUSTED attribute were a VARCHAR2(1) 'Y' or 'N'.

Y = adjusted cadastral point

N = unadjusted cadastral point

The Department has reviewed processes and impacts of maintenance including the Digital Cadastral Modernisation (DCM) outputs and their representation in Vicmap Property, it became necessary to include a value to identify adjusted points that had been moved due to new maintenance documents providing a more accurate location for the point.

The 'Y' and 'N' domain values have been modified to the three domain values in Table 1.

#### Who will it affect

This change will affect all Vicmap Property customers that receive supplies utilising the following Vicmap Property data models:

- Vicmap Property (Standard) Version 5.0
- Vicmap Property Simplified 1 Version 4.0

The Vicmap Property Simplified 2 and the Vicmap Land Administration Themes Incremental Update Format data models do not include the CAD POINT table and therefore are not affected by this change.

## When the change will occur

The modified domain values in ADJUSTED attribute will be applied 16 June 2022.
