MGA2020 Zone 54 bearings have been determined using RTK GNSS in conjunction with GPSnet. Multiple independent measurements were made to various instrument points.

CADASTRAL DATUM

'A-B-C-D' vide OP104416-8 and 'B-C' vide OP104415. All OP's are by the same surveyor (W.Casey, 1979) and on the same survey bearing datum, AMG66 Zone 54.

'A' is Ballarat PM246, 'B' and 'C' are ORM pipes and 'D' is the centre of manhole lid.

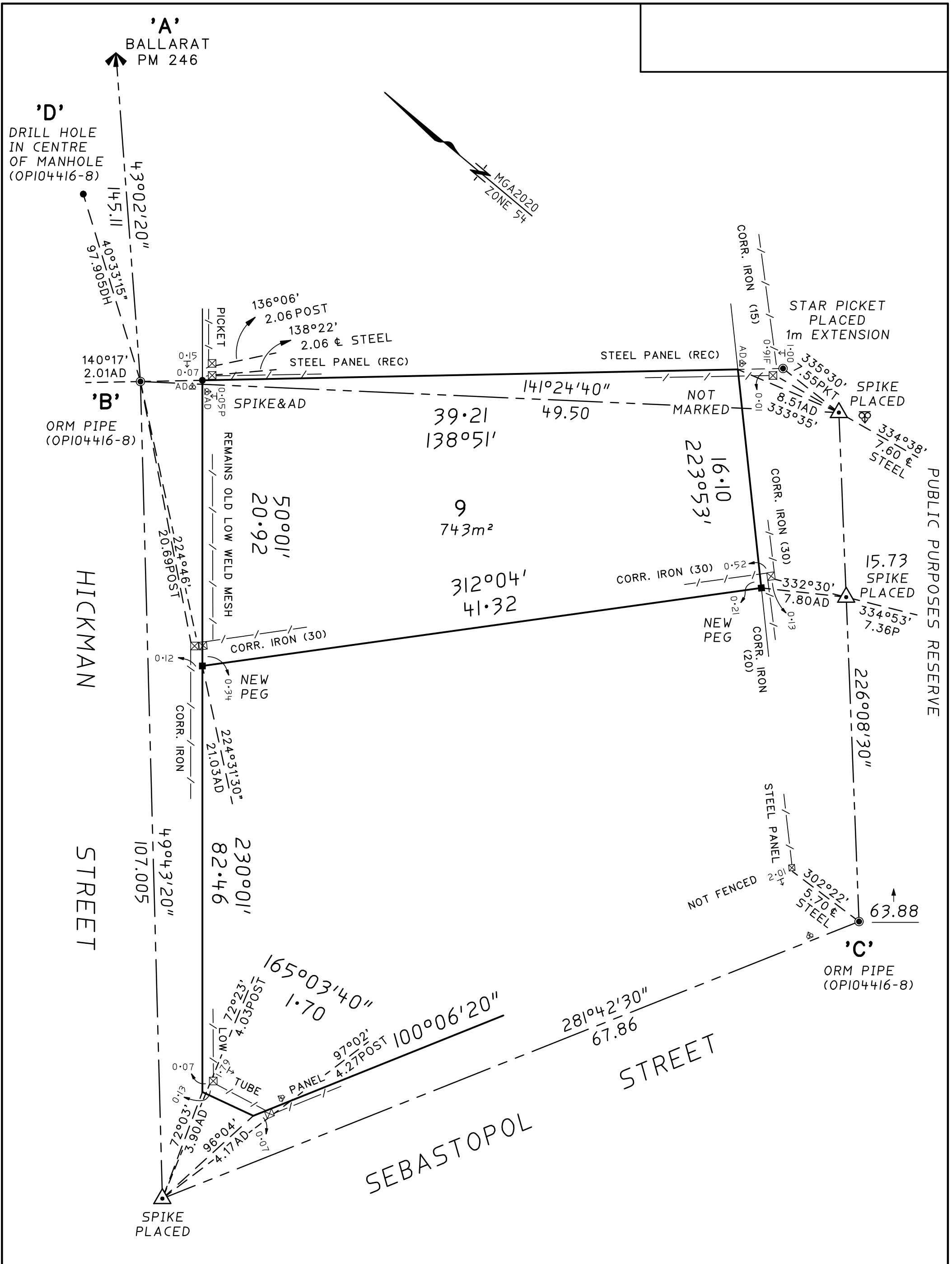
