# **Land Registry Lodging Book**

New stocks of the Land Registry Lodging Book are being printed and will be on sale early December 2006. The price will remain at \$77 inclusive of GST.

The reprinted book will be a revised version of the third edition and will include identified corrections and changes that have resulted from updates to legislation and Regulations.

For the benefit of customers who already have the third edition of the Land Registry Lodging Book, the complete list of the corrections and changes to be included in the revised version of the book is set out below.

## Throughout the book

The phrases "Legal Practice Act 1996" and "Current Practitioner under the Legal Practice Act 1996" have been replaced with "Legal Profession Act 2004" and "Australian Legal Practitioner under the Legal Profession Act 2004" respectively.

References to "Transfer of Land (Fees) Regulations 1993" have been replaced with "Transfer of Land (Fees) Regulations 2004".

References to "Subdivision (Registrar's Fees) Regulations 1993" have been replaced with "Subdivision (Registrar's Fees) Regulations 2004".

## Section 3 - Transfer of Land Act 1958

"Surveyor's Report

Abstract of field records may be required if the stage plan has been prepared by a different surveying company or is prepared more than five years after the date of the original survey".

Page 6 - Lodging Requirements - The statement "If easements or restrictions are varied or removed by the plan then the supporting documents under Section 6(1)(j) or (k) of the Subdivision Act 1988 must be produced" has been deleted.
