Change advisory notice 296 Vicmap Themes TASK_ID

Products Affected: Vicmap Address, Vicmap Admin, Vicmap Crown Land Tenure, Vicmap Elevation, Vicmap Features of Interest, Vicmap Hydro, Vicmap Index, Vicmap Transport and Vicmap Vegetation

What is happening

A new attribute TASK_ID (Table 1) is being added to multiple Vicmap tables (Table 2) to support internal maintenance, quality assurance and task identification.

Attribute	Data Type	Description
TASK_ID	INTEGER	The identifier for the process/task that updated this feature.

Why this change is occurring

This change will:

- Support internal maintenance, quality assurance and task identification.
- Support customers to better identify maintenance activity that has resulted in the feature representation within the Vicmap Products. Customers may quote this identifier along with the dataset PFI or UFI in their feedback to enable quicker identification of the recent maintenance activity that introduced the current feature representation.

Who will it affect

This change is an improvement for customers of the Vicmap datasets listed in Table 2 (above).

The addition of the new attribute does not mean that current customers need to incorporate this attribute into their systems and should not impact how they currently use these tables.

Incremental Update Format (IUF) customers will not be affected by this change.

When the change will occur

This change will be available after the release of DEECA's new Vector Data Platform (VDP). Cut over from the on-premises data centre to the VDP cloud platform is expected to be in April 2023. Vicmap with proposed changes will be published to the VDP in late April 2023. Further communication will be provided when the VDP Vicmap release date is confirmed.
