How to give a limited term transfer

An owner of a water share must apply to a water authority for approval of a limited term transfer. Once the application has been approved, the water authority will provide the seller with a pre-filled limited term transfer form, which must be signed by all parties and then lodged with the Water Registrar.

The limited term transfer must be recorded in the water register within two calendar months from the date of water authority approval. If the limited term transfer is not recorded within the two calendar months, the water authority approval lapses and the Water Registrar will not record the limited term transfer. A new application would need to be lodged with the water authority with another application fee.

Please note that you should allow a minimum of 24 hours for your transaction to be processed by the Water Registrar.

When to use the Limited Term Transfer of Water Share form

The *Limited Term Transfer of Water Share* form is used to record a limited term transfer in the water register. A limited term transfer cannot exceed 20 years.

What does it cost?

Land Victoria fees for lodging and recording your *Limited Term Transfer of Water Share* form are set out in the current Water (Resource Management) Regulations 2007 and *Your guide to most common Land Victoria water share transaction fees*.

Documents to be lodged at Land Victoria

A completed *Limited Term Transfer of Water Share* form. This form will be provided to you by the water authority on approval of your application for a limited term transfer.

If the water share is encumbered by a mortgage and the mortgage is not being discharged, consent from the mortgagee will be required. The consent must be a separate supporting document and must be lodged in conjunction with the *Transfer of Water Share* form
