# Change Advisory Notice 285 Vicmap as a Service – Change of URL for Vicmap Vegetation Tree Urban

## What is happening

The hosting environment for the Vicmap as a Service (VaaS) feature layer – Vicmap Vegetation Tree Urban - is changing which will require a URL change for the REST and WFS end points.

# Why this change is occurring

The Vicmap Vegetation Tree Urban feature layer is currently hosted on the ArcGIS Online platform due to its large storage requirement it will be moving to the Departments ArcGIS Enterprise (<u>MapshareVic</u>) platform to better manage the service.

## Who it will affect

This change will affect all users of the VaaS Vicmap Vegetation Tree Urban hosted feature layer (REST) service and WFS in GIS desktop and web mapping applications. Customers are advised to update their GIS desktop and/or web mapping applications to the new URL's specified below in Table 2.
